It's easy to schedule a virtual skills evaluation:

- >> Please collect the names and emails of students who either need to be certified/recertified at your office. NOTE: Minimum charge for Skills Evaluation Session is based on 6 students.
- Determine three convenient dates for your team to take the skills evaluation session.
- Please e-mail training@FC-Safety.com or call to schedule the skills session at 877-665-7233 x190. Every effort will be made to meet your schedule.
- Once the skills evaluation has been scheduled, our instructor will email the online course link to the students who will then have 2 to 3 weeks to complete the course prior to the skills evaluation session
- You will be billed upon class completion and each participant will be e-mailed their certification Card shortly after the Skill Evaluation session.
- Let the instructor know if you will be needing a manikin for the evaluation (sold separately)





The Value of Blended Learning

- Many previously trained responders let their certifications lapse because they cannot devote time to retake the course this format allows them the convenience to remain a responder.
- When your responders are taking the online course, they will be able to directly contact a safety and emergency care professional at FC Safety with any questions on the self-study material. All calls are strictly confidential.
- During the Skill Evaluation session, the instructor will explain to students how their state's Good Samaritan law protects them from liability and will communicate the company policy on workplace emergency response.

Requirements:

Training protocols have changed in the post-COVID19 arena. To conduct the virtual skills session, we need to make sure the student has an adequate training environment.

- The instructor and the students must be able to see and hear one another throughout class
- · If at any time video or audio is poor or lost and unable to be resolved, class should be canceled and rescheduled
- · Sound and camera positioning should allow the instructor to adequately assess all required elements of the skills throughout all skill practices and assessment scenarios.



- » Recommended distance is 3 to 4 feet between camera and manikin.
- » Recommended camera angle is roughly 45 degrees.
- » Distance and angle of camera may change depending on student and skill being performed.

Manikins:

If sanitized manikins are not available, we suggest the AHA CPR Anytime Manikin, which can be purchased through FC Safety for \$38.50 plus shipping.
